IN EXERCISE of the powers conferred on the Minister of Investment, Trade and Industry by section 31 of the Trade Act, the following Regulations are hereby made -

1. These Regulations may be cited as the Trade (Amendment) Regulations, 2016.

2. The Trade Regulations (hereinafter referred to as "the Regulations") are amended in regulation 2 by substituting for the definition of -

(a) "department store", the following new definition -

""department store" means a store which sells different categories of goods in different departments under one roof;";

(b) "supermarket", the following new definition -

""supermarket" means a self-service store which sells a wide range of food items, household goods and wines, but not beers and spirits;"; and

(c) "wholesale", the following new definition -

""wholesale" means a store which sells goods in bulk per product or

3. The Regulations are amended by substituting for regulation 9, the following new regulation -

"Department store licence

9. (1) A department store licensee shall not sell motor vehicles, petrol, diesel, paraffin, or liquefied petroleum gas in the licensed premises.

(2) The holder of a licence reserved for a citizen under regulation 30, in respect of a reserved trade or business, may carry out such trade or business within a department store owned by a non-citizen.

(3) A department store licensee shall carryout his business from a store of at least 1500 square metres.

(4) The requirement under subregulation (3) shall be specified in a department store licence.".

4. The Regulations are amended by substituting for regulation 26, the following new regulation -

"Supermarket Licence

26. (1) A supermarket licensee who has been issued with a bottle store liquor licence under the Liquor Act shall -

(a) restrict access to the section of the premises where wines are kept, by engaging a security officer to do so;

(b) have a separate cash till for the sale of wines; and

(c) comply with the conditions set out in the Liquor Act in respect of the bottle store licence.

(2) A supermarket licensee shall carry out his business from a store of at least 1000 square metres.

(3) The requirement under subregulation (2) shall be specified in a supermarket licence.".
